**When:** Saturday, May 18 and Sunday, May 19, 2019. Entries for the all stakes will close and draw at 7:30 AM Pacific Time. Dogs must be on the grounds at the time they are marked present.

**Entry Fees:**

All entries are \$25. Best Open and Absolute are free. Bitches in season may not compete with males in Combined Field Champions or for Best Open or Absolute.
