What: AKC dachshund field trial on rabbit. Two days with combined FC Class.

Where: 1377 Hining Rd, Winlock, WA. Both the trial and the draw will be held on these grounds.

Exit 63 from I-5 north or south. Go west 3 miles into Winlock. Left on Kerron St., go 1.3 miles. Left on Russel Rd, immediate left on Hining. Immediate right through the gate over the bridge onto grounds.

When: Saturday, Nov. 4 and Sunday, Nov 5, 2017. Entries for the all stakes will close and draw at 7:30 AM Pacific Time. Dogs must be on the grounds at the time they are marked present.
