Location Info Updated 5/7/18



What: AKC Dachshund field trial on rabbit. Two days with combined FC Classes.

When: Saturday, May 19 and Sunday, May 20, 2018. Entries for the all stakes will close and draw at 7:30 AM Pacific Time. Dogs must be on the grounds at the time they are marked present.

Original Location: ~~Winlock Washington Hound Grounds:~~ 1377 Hining Rd, Winlock, WA. Exit 63 from I-5 north or south.

New Location for Roll Call: **Castle Rock Fairgrounds:** (Approx. 25 minutes south of Winlock)

From I-5 North, (from Seattle & Winlock), Exit 49. Go right off the ramp onto Huntington Ave N. Travel 0.7 miles. At 4-way stop, right onto A St. Go 0.5 miles to fairgrounds entrance on Fair Ln.

From I-5 South (from Vancouver WA & Portland). Exit 48. Left off ramp onto Huntington Ave N. Travel 1.5 mi to 4-way stop. Take left onto A St. Go 0.5 miles to fairgrounds entrance on Fair Ln.

New Location for Running Grounds: **Castle Rock Grounds and Camelot Grounds.** From Fairgrounds, take a left onto A St. In 0.2 mi at the 4-way stop, turn left onto WA-411. To the Castle Rock Grounds, travel 0.7 miles and turn left onto Delemeter Rd.

To the Camelot Grounds, continue south on WA-411. At 1.5 miles from 4-way stop turn left onto Camelot Dr.
