Spring Field Trial - 2021



Events: #2021699005 (Saturday); #2021699006 (Sunday)

What: AKC Dachshund field trial on rabbit. Two days with Open All Age Bitch (OAAB), Open All Age Dog (OAAD) and combined field champion (FC) classes.

When: March 27-28, 2021. Entries for all stakes will close and draw at 8:00 AM Pacific time. Dogs must be on the grounds at the time they are marked present.

Where: The entire trial will be held off of Camelot Drive in Castle Rock, WA.

From southbound I-5, take exit 49 and turn right onto I-5 Business Loop/Huntington Ave. North and continue for 0.7 miles. Turn right onto WA-411 North/A Street and continue for ~2 miles. Turn left to remain on WA-411/Westside Hwy and continue for ~2 mile. Turn left onto Camelot Drive and stay on this road for ~2 miles. The parking area is on the right near the bathroom.

From northbound I-5, take exit 48 and turn left onto I-5 Business Loop/Huntington Ave. South and continue for 1.6 miles. Turn left onto WA-411 North/A Street and continue for ~2 miles. Turn left to remain on WA-411/Westside Hwy and continue for ~2 miles. Turn left onto Camelot Drive and stay on this road for ~2 miles. The parking area is on the right near the bathroom.

Entry Fees: All entries are \$25. Pre-entries will not be accepted. As a Covid-19 precaution, please give your entries, signed Covid-19 risk statement, and fees to the trial secretary (Chris Hamilton), then leave the area. Do not congregate around the secretary's table!

Payment: All entries will be managed at the event. Only checks (made to DFSW) or cash (exact change) will be accepted. Change will not be available but club donations will be accepted.

Prizes: Rosettes for placements including NBQ. Large rosettes for Best Open and Absolute. Dachshund related prizes will be awarded. DCA medallions and plaques will not be awarded at these events.

Covid-19 precautions: This trial must comply with State of Washington and Cowlitz County Executive Orders and Ordinances, and guidance provided by the American Kennel Club. Please do not attend this trial if you have: a fever, cough or flu-like symptoms; tested positive for COVID-19 and have not been free of fever without fever suppressing medication for 10 days; or been in direct contact with someone with COVID-19 in the past 14 days. In addition, all persons in attendance will be required wear a face covering except when eating or drinking. Efforts should be made to physically distance (6 feet or more) even when beating brush, competing with dogs in the field, and

judging. Hand sanitizer, disinfecting spray and wipes, and a cold-water hand washing station will be available. Please bring your own pens/pencils and bracing sheets.

- The Trial Committee reserves the right to change this running order for any reason. Judges will be chosen for Best Open and Absolute by the DFSW Field Trial Committee.

Bitches in season: Bitches in season may compete in the OAAB stakes but may not compete with males in Combined Field Champions or for Best Open or Absolute.

Tracking collars: Dachshunds competing in this event may wear tracking collars. The collar surface against the dog's neck must be flat (no protrusions). While under judgment, handheld tracking devices must be turned off. Handheld devices may be turned on only after the dog has been eliminated from competition by the judges or judgment has ceased.

Beating brush: Beating brush is an essential part of field trialing, and the trial cannot be conducted without brush beaters, spotters, and field marshals. Everyone needs to contribute to the success of the trial.

Meals: Due to Covid-19 restrictions, no meals will be provided. Please bring your own food and water. There is a mini-mart with a deli about a mile from the trial grounds. In addition, please bring your own chairs and shade.

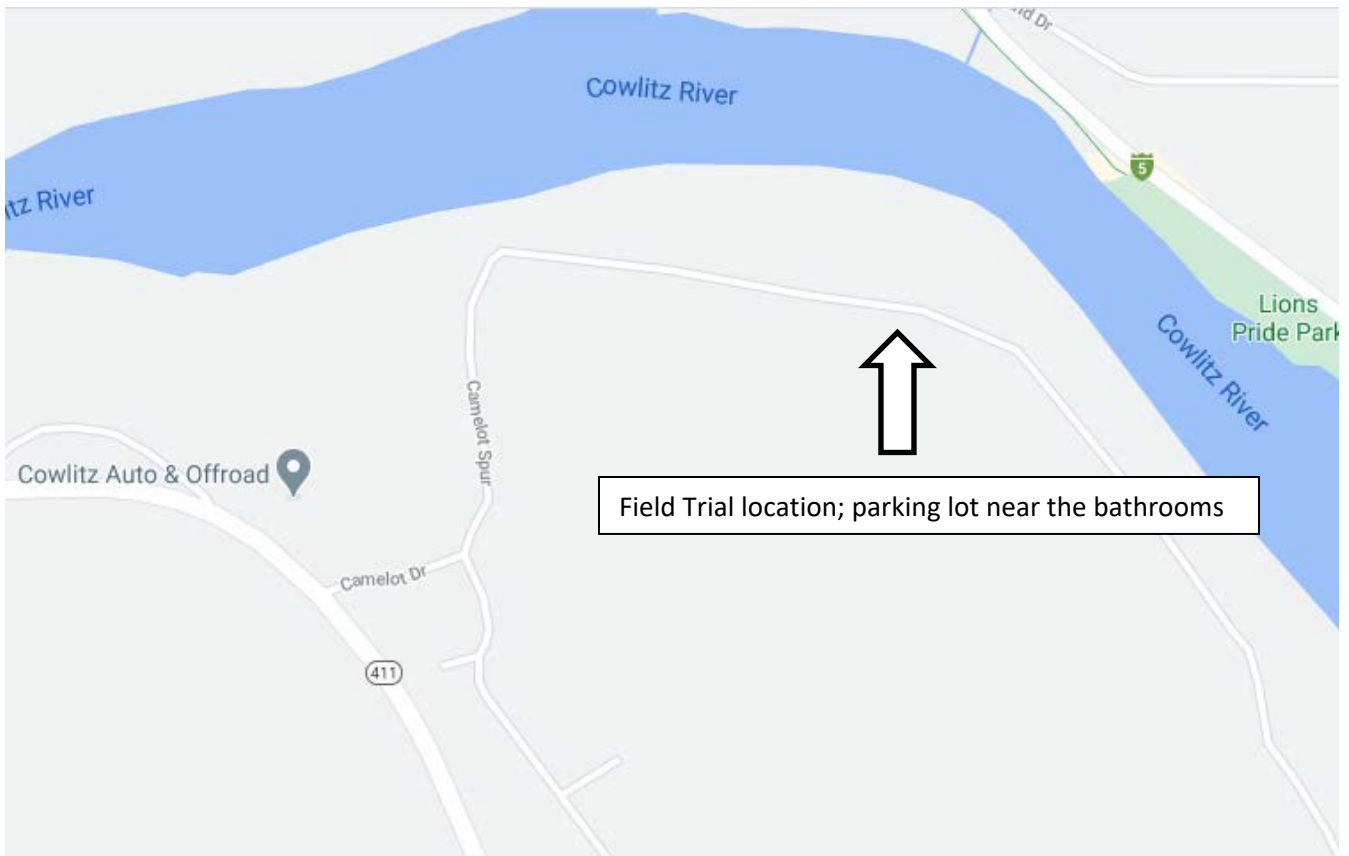
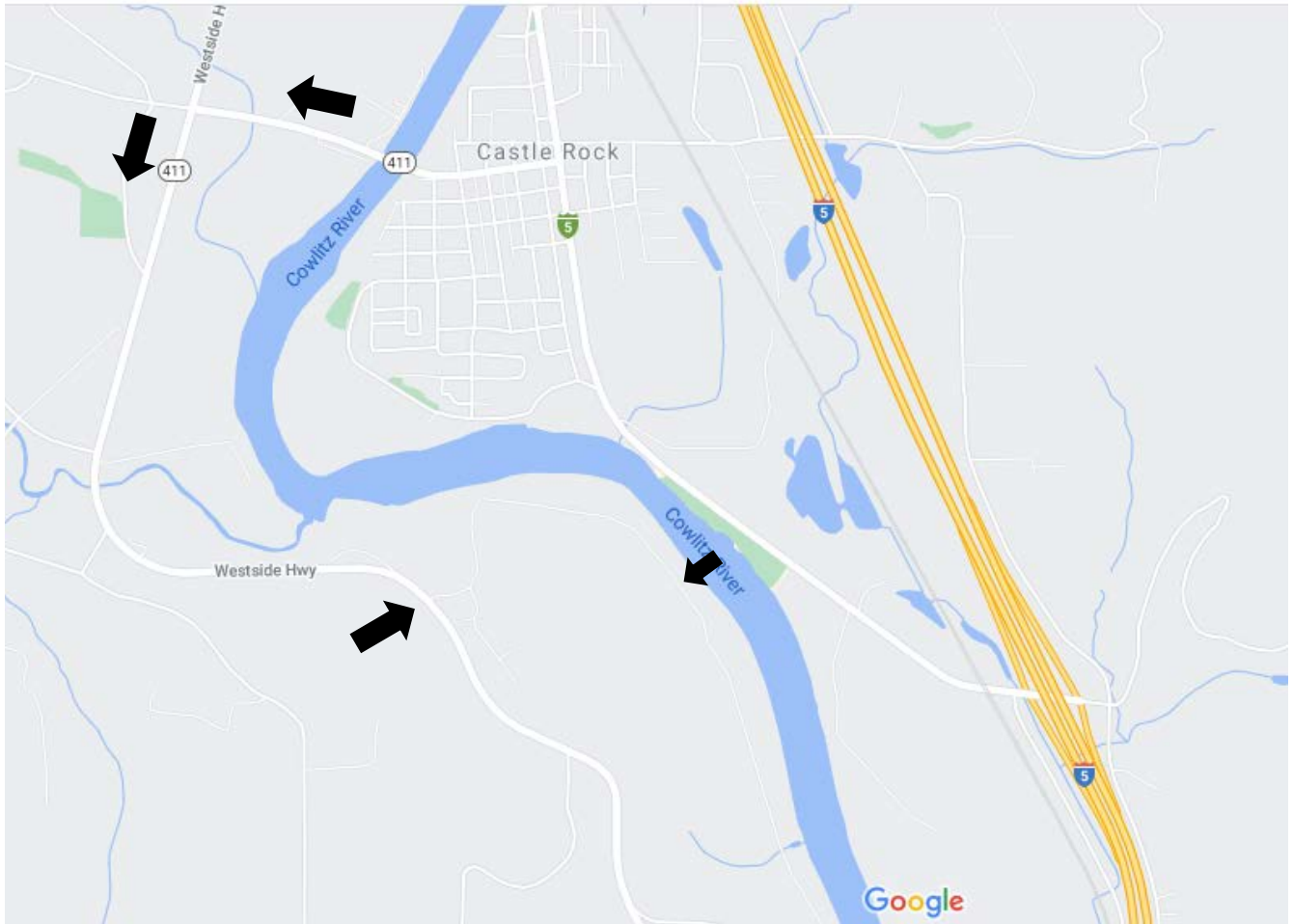
