**What:** AKC Dachshund field trial on rabbit.

**CERTIFICATION:** Permission has been granted by the American Kennel Club for holding this event under American Kennel Club Rules and Regulations. ~ James P. Crowley, Secretary

**When:** Sunday, April 13, 2025. Entries for all stakes will close and draw at 7:45 AM Pacific Time. Dogs must be on the grounds at the time they are called.

**Where:** The draw will be held at the Castle Rock Fairgrounds in the small room.

**Entry Fees:** All entries are \$25.00 per dog.  
**Juniors are \$10.**

**Payment:** All entries will be managed at the event. Check (made to DFSW) or cash (exact change) additionally, digital payments are acceptable. Venmo and Zelle and (PayPal with a \$4 fee) will be fine.

**Prizes:** Flat ribbons for placements including NBQ. Rosettes for Best Open and Absolute. Big Stinkies will be awarded all placements. New Field Champion Ribbons are available for those dogs completing their field championship at our events.

**Meals:** Our usual meal extravaganza will be at Saturday dinner, and leftovers for Sunday lunches. Please bring something to share!

### **Directions to 120 Fair Lane, Castle Rock WA 98611**

From I-5 N or S: take Exit #48 (Business Loop/Castle Rock). Go west at bottom of ramp onto Huntington, at center of town right onto A, after bridge construction, immediate left on Fair Lane. You will see cars and RVs etc.

### **Lodging:**

RV spaces are available at the fairgrounds. \$20 per day with electricity, \$10 without. Contact Claire Mancha at [claire@whiz.to](mailto:claire@whiz.to) for reservations. Judges stay for free on their judging day. You are welcome to tent camp on site. Winlock will be available to those who bring their own bedding. ***There is NO bedding at Winlock.***

**Hotels:** There are hotels in Kelso / Longview and one in Castle Rock. It is your responsibility to find out if they accept dogs.

**Bitches in season:** Bitches in season may compete in the OAAB stakes but may not compete with males in any subsequent runs.

**Tracking collars:** We allow dachshunds to wear tracking collars at these field trials. The collar surface against the dog's neck shall be flat (no protrusions). While the dachshunds are under judgement handheld devices must be turned off. Handheld devices may be turned on only after the dachshund has been eliminated from competition by the judges or judgement has ceased. Procedure 3D of Dachshunds in the rule book is still in effect (page 19).

**Beating brush:** Beating brush is an essential part of field trialing, and the trial cannot be conducted without brush beaters, spotters, and field marshals. Help us help you put titles on your dogs!
